

TRANSFER ARTICULATION AGREEMENT

and

**The American Women's College
at Bay Path University**

to

B.S. in Health Services Admin/Health Sciences

Statement of Purpose

Bay Path University (BPU) and Holyoke Community College (HCC) recognize that, for many students, the path to a bachelor degree may begin at a community college. Moreover, for HCC's female students, diverse educational opportunities, including the advantages of enrolling in a women's university to earn a bachelor's degree, adds great value to educational experiences. This agreement acknowledges that significance and is formed to enable the smooth transfer of Holyoke Community College graduates to Bay Path University's The American Women's College offered online and at its two ground campuses.

Further, the purpose of this agreement is to provide smooth transition between the two academic programs by:

- identifying all required and equivalent courses for the relevant programs at each institution, and
- facilitating credit transfer and guarantee of admission for students who meet the agreed upon criteria.

Participants

This agreement has been entered into by Holyoke Community College, Holyoke, MA, and Bay Path University for programs offered through The American Women's College, which offers degrees of study both online and at its campuses located in Longmeadow and in Sturbridge, MA. The B.S. in Health Services Admin/Health Sciences through The American Women's College is available online only.

Programs/Courses Included in This Agreement

- A) Holyoke Community College's A.A. in Foundations of Health Transfer will be accepted toward Bay Path University's B.S. in Health Services Admin/Health Sciences.
- B) This acceptance will be offered to HCC students who enroll at The American Women's College at Bay Path University's fully online program for undergraduate students.
- C) Coursework and credits from HCC's A.A. in Foundations of Health Transfer that will be accepted and applied towards required coursework and electives for the B.S. in Health Services Admin/Health Sciences at TAWC will be outlined on the advising guide included in Appendix A.

Terms and Conditions of Transfer

- A) Students who graduate from the HCC's A.A. in Foundations of Health Transfer degree with a cumulative grade point average (GPA) of 2.0 or higher will be guaranteed admission into the B.S. in Health Services Admin/Health Sciences degree under the terms of this agreement.
- B) The BPU Admissions Deposit will be waived.
- C) All coursework from the sending program must be completed with grades of "C-" or better in order to transfer.

- D) HCC students who have taken courses beyond the requirements of their A.A. in Foundations of Health Transfer may request an evaluation of additional earned credits for eligibility and acceptance into the B.S. in Health Services Admin/Health Sciences degree program. However, all students must complete 30 credits at Bay Path University to satisfy residency requirements.

Communications and Advising

Communication and advising is central to effective transfer/articulation. Recognizing this:

- A) The college and university agree to include information about this articulation agreement in relevant publications for the purposes of promotion and advising.
- B) The college and university agree to jointly develop appropriate transfer guides and make these available to students and advisors as appropriate.
- C) The college and university agree to notify each other promptly, in writing, of substantive changes in curricula that might affect the Agreement.

Implementation and Length of Agreement

- A) Bay Path University and Holyoke Community College agree that this Agreement becomes effective on January 1, 2019 and is applicable to eligible students in the next semester of enrollment.
- B) This agreement will remain in effect for three years from the date above unless terminated or amended by a signing representative below, from either institution, with prior written notice.
- C) This agreement does not preclude either college from entering into similar agreements with other institutions of higher education.
- D) This agreement may be amended by addendum as necessary. This means that as requirements and courses change over time this agreement may stay in force as long as the program managers, their academic supervisors, and the transfer counselors agree in writing to the change.

Signatures of Institutional Leaders and Representatives

The relevant program coordinator and/or academic department chair of each institution will be responsible for implementing this agreement, for identifying and incorporating any changes into subsequent agreements, and for conducting a periodic review of this agreement.
