

ACADEMIC ARTICULATION AGREEMENT

A.S. in Nursing at Holyoke Community College, Holyoke, MA, and B.S.N. in Nursing (RN- BSN Program) at Elms College, Chicopee, MA

The above institutions hereby enter into an agreement for the transfer of Holyoke Community College graduates from the A.S. in Nursing degree program into the Elms College RN- BSN program.

Objectives of this Agreement:

- 1. To attract qualified candidates from Holyoke Community College (HCC) to matriculate full-time and part-time in the online RN-BSN program offered by Elms College.
- 2. To promote a seamless transition for students from HCC's Associate degree in Nursing program to full-time or part-time status in the Elms College online RN-BSN program.
- 3. To provide program information and procedural guidelines for students at Holyoke Community College who plan to enroll in the RN-BSN program at Elms College.
- 4. To encourage academic coordination, collaboration, and joint academic advising between the faculty in the HCC Nursing Department and the Elms College School of Nursing.
- 5. To offer HCC students the opportunity to transfer up to 90 credits into the online RN-BSN program at Elms.

Stipulations of this Agreement:

- 1. This articulation agreement will be in effect for five years, with an option to renew for an additional five years by consent of Holyoke Community College and Elms College. This articulation agreement can be reviewed within 90 days after written notice by either party.
- 2. Elms College provides the opportunity for HCC students to complete the Bachelor's in Nursing (BSN) degree through the RN-BSN program in as little as 12 months full-time from the date of enrollment.
- 3. This articulation agreement will be in force, and should be considered the entire agreement,

until superseded by a formal contract between Elms College and Holyoke Community College that explicitly replaces this agreement.

- 4. This agreement will apply to Holyoke Community College transfer students who have completed an Associate's degree.
- 5. This agreement guarantees that students who earn an Associate's degree in Nursing at Holyoke Community College will enter Elms B.S. in Nursing (RN-BSN) Program with at least 70 transfer credits, if available. All additional courses taken to satisfy major requirements must meet the standards set by Elms College. **PLEASE SEE ATTACHMENT A**.
- 6. Transfer students to the Elms College RN-BSN program may transfer up to a maximum of 90 credits for which students have achieved a "C" grade or better within the past 10 years. Elms College requires that a minimum of 30 credits must be Elms credits earned as a matriculated Elms College student.
- 7. HCC students will be given transfer credit for satisfactorily completing Elms College core requirements, general education requirements, and any acceptable equivalent RN-BSN program requirements, up to the maximum allowed for transfer or necessary to satisfy graduation requirements, at time of admission.
- 8. The final acceptance of applicants comes from the Director of the CE and Graduate Admissions Office.
- 9. The Dean of Nursing at Elms College and the Dean of the Health, Education, Culinary Arts & Human Services Division may make changes to the attached list of courses accepted for Elms transfer credit without renegotiating the entire agreement.

Mutual Responsibilities:

- 1. Holyoke Community College and Elms College will list this articulation agreement on their websites and in appropriate print documents at their respective institutions.
- 2. Holyoke Community College and Elms College will collaborate in encouraging qualified students to participate in the RN-BSN program at Elms College by providing the necessary assistance and supports to assure a seamless transition between the two institutions.
- 3. The Director of Nursing, nursing faculty and the Transfer Counselor at HCC will advise students enrolled in the A.S. in Nursing programs at HCC. The attached list of courses accepted for Elms College transfer credit assures maximum transfer of credits that meet the

core requirements of Elms College Bachelor of Science in Nursing (RN-BSN) degree requirements.

- 4. The Director of the RN-BSN Program at Elms College, along with staff from the CE and Graduate Admissions Office will advise and assist transfer applicants in compiling the required credentials for transfer to the Elms College RN-BSN program.
- 5. Transfer applicants from Holyoke Community College applying under this agreement shall be eligible for Elms College financial aid consideration as appropriate based on full-time or part-time status.
