#### **MEETING**

I. Call to Order: Interim Chair Smith called the 435<sup>th</sup> meeting of the Holyoke Community College Board of Trustees to order at 8:05 am.

#### II. Roll Call

Interim Chair Smith welcomed everyone.

#### III. Consent Agenda

#### Roll Call Vote for Consent Agenda

A motion was made by Trustee Hebert and seconded by Trustee McGee to accept the Consent Agenda as presented.

#### IV. Committee Reports

#### A. Audit and Finance Committee

Trustee Epstein stated that the Audit and Finance Committee have updated the investment policy statements that were outdated for a considerable period of time with both money managers, so that keeps the college in line with being up to date on due diligence. He stated that they had really great meetings back and forth with the managers in terms of their allocation strategy. Vice President Sampath stated they're discussing fees at the March meeting and the other financing.

#### B. By-Laws and Governance Committee

Trustee Vidal stated that she, along with President Timmons and Trustee Rosa attended the ACCT National Legislative Summit in Washington, DC last week. She gave an update that this Summit was a wonderful opportunity to meet other trustees from other colleges and network with them. Trustee Vidal also stated that the Committee is planning a summer retreat for the Board and everyone will receive more information in the coming weeks.

#### C. Equity Committee

Trustee Johnson reported that there were no updates. The Committee is in the process of coordinating the next meeting.

#### D. Foundation Board Update

Trustee Hebert thanked Amanda Sbriscia, Julie Phillips and Laura White for a great luncheon and presentation for donors that was recently held at the Culinary Arts Institute. It was the first time hosting donors and reviewers, and a great opportunity, and encouraged every board trustee member to fuel our students for scholarship. It's a great opportunity to get to know the students and their needs and concerns and to meet everyone.

#### E. Nominating and Presidential Evaluation Committee

Interim Chair Smith said the process of the nominating and Presidential Evaluation Committee would be starting soon, as the Board has had the departure of two from that committee, and will be reaching out and looking for people to participate in that committee. The whole board does get a chance to participate in Dr. Timmons' evaluation. From the nominating standpoint, Dr. Timmons and Interim Chair Smith continue to meet with potential candidates, as it is a relatively new process in the last year or two, being hybrid, with a statewide format, and having traditionally worked with a consultant in the past, Liz Denney, with the final report being sent to the Commissioner.

F. Strategic Planning Committee – No Updates

#### V. President's Report

President Timmons gave the following updates:

- As stated earlier, during the week of February 10th, he, along Trustees Nayroby Rosa and Ivonne Vidal, attended the American Association of Community Colleges (ACCT) National Legislative Summit in Washington D.C. This summit focuses on the national priorities of community colleges, one of which is rejecting risk sharing, as well as support for Pell Grants, and bolstering the role of community colleges in Workforce Development. He stated that our team also had the opportunity to meet with Congressman Neal and Senator Warren. (Trustee Rosa and Trustee Vidal said a few words about their experience attending this summit).
- The College is requesting a \$100,000 earmark from Senator Velis and Representative Duffy to enhance workforce development initiatives. The investment will target the healthcare, financial/insurance businesses, and manufacturing industries.

- President Timmons stated that on February 3<sup>rd</sup>, HCC hosted a Legislative Breakfast where he, along with cabinet members, facilitated open conversations around key topics such as enrollment and retention, workforce programming, and legislative priorities. Nine elected officials or their designees participated, as well as Nate McKinnon, the Executive Director for MACC. The conversation was followed up with a tour of the campus.
- The College recently received notification that the college has won a national award from NASPA, an organization for Student Affairs Administrators in Higher Education. It was the NASPA 2025 Excellence Award Category Silver Honoree in the area of assessment, persistence, and data analytics. HCC is one of two community colleges receiving this award among 4-year colleges.
- On February 18, President Timmons, as well as Dr. John Cook, President of Springfield Technical Community College, were interviewed by John Dobbs, from Focus Springfield during the Government Matters segment. They were able to share their outlook on higher education access, affordability, programs, and the value of community colleges in regional economies. Thank you to Stephen Cary for the invitation and the opportunity to share.
- President Timmons also stated that on February 19, there was a Scholarship Luncheon held at HCC/MGM Culinary Arts Institute. It was the College's way of expressing gratitude and thanks to donors and scholarship reviewers for their time. Scholarship recipients were present to allow donors to see the impact of their kindness and support of our students, as well as take part in a wonderful meal prepared by our students.
- President Timmons and the cabinet are continuously monitoring the activities coming out of Washington, DC and how it may impact HCC's operation, and is in regular contact with Interim Board Chair Smith. During the last four weeks, a letter was sent to the campus community stating the commitment to HCC's mission, values, and vision. President Timmons and the Cabinet will continue to give updates as the college receives guidance from the governor's office.
- A Community Forum was held on Thursday, February 13<sup>th</sup> with a presentation on Know Your Rights Workshop from Susan Church, Chief Operating Officer from the Office of Refugees and Immigration with the State of Massachusetts. This Forum allowed members of the HCC community to express any concerns. President Timmons also stated that he and the Cabinet participated in a webinar from the American Association of Community Colleges, that provided updates on the latest developments, including federal funding, budget reconciliation legislative, executive orders, and other administrative actions.
- President Timmons congratulated Lauren LeClair and Kim Straceski for presenting at the
  Achieving the Dream National Conference with their presentation entitled, Expanding Access to
  Financial Support Through Early Alerts, and also congratulated Julie Phillips on completing her
  Master's in Higher Education, with a focus on Advancement, from Bay Path University.






